**Note:** Transmission classification is based on WHO's analysis of available official data and may be subject to reclassification as additional data become available. It should be noted that even within categories, different countries/territories/areas may have differing degrees of transmission as indicated by the differing numbers of cases and other factors. Not all locations within a given country/territory/area are equally affected.

**Local transmission** indicates locations where the source of infection is within the reporting location.

**Imported cases** only indicates locations where all cases have been acquired outside the location of reporting.

**Community transmission** is evidenced by the inability to relate confirmed cases through chains of transmission for a large number of cases, or by increasing positive tests through sentinel samples (routine systematic testing of respiratory samples from established laboratories)
