PAHO AWARD FOR ADMINISTRATION (2013)

REPORT OF THE AWARD COMMITTEE OF THE PAHO AWARD FOR ADMINISTRATION (2013)

1. The Award Committee of the PAHO Award for Administration (2013) is composed of the Delegates of Canada, Chile, and the United States of America.
2. The Committee met on 18 June, during the 152nd Session of the Executive Committee, and examined the information on the single candidate nominated by Member States, namely:

3. The Committee recommended that the PAHO Award for Administration (2013) be awarded to Dr. Brendan Courtney Bain, of Jamaica, for his extensive contributions in administration and his work to strengthen the public health workforce in the Caribbean through education, training, and research. He has headed the Centre for HIV/AIDS Research, Education and Services at the University Hospital of the West Indies in Kingston, and currently serves as Director of both the Regional Coordinating Unit of the Caribbean HIV/AIDS Regional Training (CHART) network and the Caribbean Health Leadership Institute (CHLI). As Professor of Community Health, he initiated education and training in Clinical Infectious Disease at the University of West Indies and organized the first sensitization workshops on HIV/AIDS across Jamaica. Through his important research, he has studied HIV prevention and explored the psychosocial ramifications of HIV and AIDS, reinforcing the need for a whole-person approach to HIV/AIDS care and treatment.
