SYSTEMATIZATION OF THE MANDATES OF THE PAN AMERICAN HEALTH ORGANIZATION

Introduction

- 1. In 2013, during its 153rd session, the Executive Committee requested that the Pan American Sanitary Bureau ("the Bureau") develop a tool for organizing and systematizing the mandates of the Pan American Health Organization (PAHO) that would enable the Member States and other stakeholders to monitor progress on international commitments to public health.
- 2. The Executive Committee also requested that the Bureau organize the information on the resolutions and documents approved by the Governing Bodies of PAHO consistent with the PAHO Strategic Plan. This arrangement of the information would make it possible to analyze the complementarity and execution of the mandates issued by both PAHO and the World Health Organization (WHO) over time.
- 3. This document presents information on the PAHO/WHO Institutional Repository, a digital documentation system for preserving and searching institutional memory. It also presents a report on the assessment done by the Bureau on the resolutions adopted by PAHO over the past 15 years (1999-2013) in order to determine whether these resolutions can be classified as "active," "conditional active," or "sunset" (see Table 1).

PAHO/WHO Institutional Repository

4. The PAHO/WHO Institutional Repository for Information Sharing (IRIS) is a joint PAHO and WHO initiative that was launched in 2011 for the purpose of managing, preserving, and disseminating the knowledge generated by the entire Pan American Health Organization. It therefore houses the information generated by Headquarters in Washington, D.C., the Representative Offices in the countries, the subregional offices, and the Pan American centers.

- 5. The system makes it possible to organize documents by community¹ and to perform global or limited searches by specific topic, document type (strategy, plan of action, resolution, etc.), document number, date, author, or series.
- 6. It uses the DSpace platform, an open-source software package used by academic organizations, nonprofits, and other similar institutions to create open-access digital repositories.
- 7. The PAHO/WHO Institutional Repository is a byproduct of the Organization's strategy to preserve its information legacy and provide access to it. The Bureau is in the process of digitizing and archiving most of PAHO's technical documentation.
- 8. In response to a request by Member States for a specific platform for Governing Bodies' documents, the Bureau created a community known as "Governing Bodies" in which to archive the documents of the Directing Council and Pan American Sanitary Conference since PAHO's creation in 1902.
- 9. A demonstration of the system was given to the 154th Session of the Executive Committee. The digitization and archiving of the Governing Bodies' documents and resolutions is almost complete and the system will be launched during the 53rd Directing Council. Member States can access the PAHO/WHO Institutional Repository for Information Sharing through a link on the PAHO Governing Bodies Web page.

Analysis of PAHO Resolutions (1999-2013)

- 10. The Director of the Bureau decided to conduct a study on progress in executing the mandates emanating from the resolutions adopted by the Organization's Governing Bodies over the past 15 years (1999-2013). The Director's decision responds to the request of the Member States during the 153rd Session of the Executive Committee; the WHO reform (1) and the Twelfth General Programme of Work, 2014-2019 (2), approved by the World Health Assembly in May 2013; as well as the similar exercises conducted by the WHO Regional Offices in Europe (EURO) (3) and the Eastern Mediterranean (EMRO) (4).
- 11. For this study, the Director commissioned the office of the Deputy Director to form an interprogrammatic working group comprised of representatives from all the technical departments and a representative from the administrative departments.
- 12. This effort marked the first time a review of the status of implementation of resolutions of the WHO Regional Committee for the Americas was undertaken.

Methodology

- 13. The working group developed the following methodology for analyzing the resolutions adopted by the Directing Council and the Pan American Sanitary Conference:
- a) Determine the period of analysis of resolutions (1999-2013).
- b) Establish criteria for determining whether a resolution can be classified as active, conditional active, or sunset (see Table 1).

Table 1. Criteria for determining the classification of resolutions

Active	Conditional Active	Sunset
All resolutions whose stipulated lifespan remains in effect.	All resolutions whose lifespan has ended, but it is unknown whether compliance with some commitment is pending, due to a lack of information at the time of the study or some other reason.	All resolutions that, by their very nature, do not require subsequent monitoring (e.g., the election of the members of a committee, subcommittee, working group, etc.; approval of the scale of quota assessments; approval of the Director's salary or modifications to the Staff Rules or Financial Rules and Regulations).
All resolutions whose commitments have not been met or renewed in a subsequent resolution and whose continuity is deemed important.	All resolutions that are no longer relevant, even though some of their commitments have not been met.	All resolutions whose lifespan has ended ² and whose commitments are considered to have been met ³ or have been revisited in a subsequent resolution.
-		All resolutions whose lifespan has not been stipulated, but the conditions that gave rise to them are considered to have changed, making them irrelevant. ⁴
		All resolutions that have been superseded by another more recent one.

c) Base the review on the categories and program areas of the PAHO Strategic Plan 2014-2019 (see Annex A).

When the resolution or the document endorsed or approved by the resolution clearly stipulates the lifespan, that information should be included in the analytical section of the resolution.

³ The working group shall review all operative paragraphs in each resolution and determine whether each commitment made by the Member States and Bureau has been met, whether there is no information at the time of the study, or whether the commitment remains in force.

⁴ For the purposes of this study, a resolution is considered to be relevant if it meets one or more of the following criteria: a) the subject is included in the PAHO Strategic Plan 2014-2019; b) the preamble section of the resolution is still valid; c) it is explicitly related to the global mandates of an international organization of importance to PAHO; d) it calls for PAHO technical cooperation at the regional level.

- d) Analyze the resolutions according to the following aspects:
 - i. <u>Lifespan</u>: whether the resolution or document endorsed by the resolution explicitly includes time-marked information.
 - ii. <u>Replacement</u>: whether the resolution was superseded by another more recent one, in which case the one that superseded it shall be noted.
 - iii. <u>Compliance with mandates</u>: whether each commitment established for the Bureau and the Member States has been met or whether the mandate remains in force. If information was unavailable at the time of the study, this shall be stated in the report.
 - iv. <u>Progress reports</u>: whether the resolution or the document endorsed by the resolution stipulates the periodicity with which progress reports must be submitted. If so, it shall be determined whether the reports were submitted as stipulated.
- e) Issue a recommendation for each resolution pursuant to its findings, and submit the recommendations and the study to the Director for review.
- f) Submit a report on the study of resolutions to the 53rd Directing Council in September 2014.
- 14. Resolutions were classified per category of the PAHO Strategic Plan 2014-2019 (Annex A), and were reviewed from the oldest to the newest. For those resolutions pertaining to cross-cutting categories, the working group placed them in the category in which they had the highest number of mandates, but examined the resolution in an interprogrammatic way.


Results

- 15. The assessment concluded that a total of 255 resolutions were adopted by the PAHO Directing Council and the Pan American Sanitary Conference in the 15-year period of 1999-2013. Annex B contains a summary report of all the resolutions by category, including the number, title, year of adoption and finalization, type of document, reporting requirement, progress reports presented to the Governing Bodies, recommendation, and justification for the recommendation. It also identifies when any of the information was not available.
- 16. The complete assessment, including a consolidated record of the Bureau's and Member States' commitments over the past 15 years, will be available in English in the PAHO/WHO Institutional Repository.
- 17. Each resolution was examined mandate by mandate. In most cases, the Bureau was able to identify progress made in mandates applicable to the Bureau. However, regarding the Member States mandates, in some instances sufficient information on compliance was not available.

18. A summary of the results of the review is displayed in Table 2 according to the categories of the PAHO Strategic Plan 2014-2019.



19. According to the defined methodology and as shown in Figure 1, the working group proposes to maintain 107 resolutions active (41.9%), maintain 9 conditional active (3.5%), and sunset 139 (54.5%). For those resolutions with a conditional active status, further discussion is needed to determine how to deal with the pending mandates and to decide the way forward.




20. As shown in Figure 2, out of the total 255 resolutions, Category 6, Corporate Services/Enabling Functions had the highest number of resolutions (121, or 47.5%); followed by Category 4, Health Systems (35, or 13.7%); Category 3, Determinants of

Health and Promoting Health throughout the Life Course (33, or 12.9%); Category 1, Communicable Diseases (31, or 12.1%); Category 2, Noncommunicable Diseases and Risk Factors (22, or 8.6%); while Category 5, Preparedness, Surveillance, and Response had the lowest number (13, or 5%).



- 21. The recommendations of the working group, as shown in Figure 3 below, are as follows:
- a) In <u>Category 1</u>, close 16 resolutions (51.6% of the resolutions in this category), maintain 13 active (41.9%), and maintain 2 as conditional active for further review.
- b) In <u>Category 2</u>, close 5 resolutions (22.7% of the resolutions in this category), and maintain 17 active (77.2%).
- c) In <u>Category 3</u>, close 10 resolutions (30.3% of the resolutions in this category), maintain 22 active (66.6%), and maintain 1 as conditional active for further review.
- d) In <u>Category 4</u>, close 13 resolutions (34.3% of the resolutions in this category), maintain 18 active (54.3%), and maintain 4 (11.4%) as conditional active for further review.
- e) In <u>Category 5</u>, close 6 resolutions (46.2% of the resolutions in this category), maintain 6 active (46.2%), and maintain 1 as conditional active for further review.

f) In <u>Category 6</u>, close 90 resolutions (74.4% of the resolutions in this category), maintain 30 active (24.8%), and maintain 1 as conditional active for further review.



22. The working group considered it necessary to separate the analysis of "sunset" resolutions in Categories 1 to 5 from Category 6 since this category corresponds to Corporate Services/Enabling Functions. Of the 49 resolutions which the working group considered as "sunset" in Categories 1 to 5, 44 were superseded by another resolution (and thus the pending mandates continue to be active in a more recent resolution); the remaining 5 have expired, have commitments that have been met, or are no longer relevant. In the case of Category 6, out of the 90 resolutions proposed for sunsetting, 28 were superseded by another resolution, 41 are resolutions that do not require subsequent monitoring, and 21 have expired or have commitments that have been met.

Conclusions

Limitations

23. The working group found some limitations in the identification of compliance of mandates by Member States and by the Bureau, especially regarding the oldest resolutions. Until recently, resolutions and documents did not include the specification of the type of document (policy, strategy, plan of action, or other). For these cases, the working group used the current classification followed by PAHO's Governing Bodies whenever possible. Another weakness in older resolutions and documents was the lack of information on reporting requirements and on financial implications.

Recommendations

- 24. Although there is a notable improvement in the harmonization of documents and resolutions in the last years, there is still the need to strengthen the focus of PAHO initiatives and mandates towards the achievement of the Strategic Plan and the Health Agenda for the Americas. In order to be more transparent and accountable, future resolutions need to be more explicit in including reporting requirements, clear mandates, capacity for implementation, and financial implications.
- 25. Further in-depth review of some resolutions and mandates should be considered, especially for those in which information was not available to confirm the compliance of mandates, and for those for which no progress reports have been presented to the Governing Bodies.
- 26. Every three years, the Bureau will present progress reports on the compliance of resolutions.

Action by the Directing Council

27. The Directing Council is invited to take note of this report and formulate the recommendations it deems pertinent.
