HIGHLIGHTS

- **In the Region of the Americas, no new country/area/territory** reported COVID-19 cases.
 - **The United States of America** which represents over 80% of the cases and 86% of the deaths in region did not update their case numbers in the past 24 hours. The State of New York which contributes to 50% of the total cases in the US declared a complete lock down as of 20 March banning all non-essential work commute among other measures.
 - Four (4) countries/territories with previously confirmed COVID-19 cases reported their first COVID-19 related deaths – one death each was reported in **Chile, Curacao, Paraguay, and Puerto Rico**. Brazil, Ecuador and Canada all reported additional deaths.
 - **Turks and Caicos** which has not reported any confirmed cases reported five (5) suspected cases of COVID-19 – a mix of potential local (1) and imported (4) cases.
 - **Trinidad and Tobago** is quarantining 40 positive cases among 68 individuals who were on a cruise ship and were flown in from Guadeloupe.
- **Globally**, an additional 49,484 cases of COVID-19 and 2,337 related deaths were reported in the past 48 hours from 175 countries/areas/territories of which, 15,149 cases and 826 deaths were reported in the past 24 hours.
- **In the past 24 hours, Italy reported their highest number of COVID-19 deaths** reported in one day – 793 new deaths between 20 – 21 March, for a total of 4,825 deaths. This is higher than the previous record – also set by Italy on 20 March with 627 new deaths between 19 and 20 March.
- **In China**, there were 0 confirmed local cases for a third consecutive day since the outbreak began. Seven (7) new deaths were reported from Hubei (6 in Wuhan). A total of 41 new imported cases were reported.
- **Top 10 countries with the highest number of cumulative cases:** China (81300), Italy (41035), Iran (Islamic Republic of) (19644), Spain (17147), Germany (10999), France(10877), United States of America (15,219), Republic of Korea (8652), Switzerland (3863), The United Kingdom (3277)

Note: Transmission classification is based on WHO's analysis of available official data and may be subject to reclassification as additional **Local transmission** indicates locations where the source of infection is within the reporting location.

Imported cases only indicates locations where all cases have been acquired outside the location of reporting.

Community transmission is evidenced by the inability to relate confirmed cases through chains of transmission for a large number of cases, or by increasing positive tests through sentinel samples (routine systematic testing of respiratory samples from established laboratories)
