## **Situation Overview**

- An estimated 16,000 20,000 persons affected
- Approximately 30 villages evacuated
- An estimated 75 shelters operating, with 3,200 persons
- Approximately 137 Active COVID-19 cases<sup>1</sup>
- The entire island is covered in ash with some areas experiencing extremely poor visbility. Ash is a major concern at the moment, especially in the North of the country.
- Roofs of several houses are also collapsing due to the heavy volcanic ash particles<sup>2</sup>
- Saint Vincent and the Grenadines (VCT) government booked about 800 rooms across hotels and guest houses to accommodate evacuees.
- No official closure of businesses to facilitate persons accessing supermarkets and pharmacies and to allow for the continuation of essential services
- Persons are stuck in the red zone on the windward side due to poor visibility and some roads are damaged<sup>3</sup>
- Preliminary reports also indictae that a number of Owia residents tried to evacuate by sea but conditions are not permissible.
- Health Care Facilities in the red and orange zones have been evacuated. Patients who require specialist care dialysis and chemotherapy will receive treatment at the Milton Cato Memorial Hospital in Kingstown
- Explosive volcanic ash cloud transported by wind and affected as far as Barbados since late evening Friday, April 9, 2021 and continues.




Figure 1. Map showing location of Health Care Facilities

# **General Challenges**

- Persons to be evacuated from the red zone
- Explosive eruption/gas/ashes/tremors hampering ongoing evacuations (to the south of VCT and to neighboring member states) and humanitarian efforts
- Extensive damage/disruption to infrastructure; facilities and services (incl. airport closure)
- Extensive damage to assets and livelihoods (fisheries; agriculture)
- Insufficient/inadequate hygiene. WASH facilities at shelters to cope with number of evacuees
- Limited/temporary accommodation available to host evacuees
- · Insufficient food supplies to address needs for an extended response

- · Insufficient capacity of host countries to provide support to evacuees for medium-, long-term support
- Closure of Grantley Adams International Airport in Barbados until at least 6 a.m. on Sunday April 11, 2021. Further logistic challenges are foreseen.

# **Health Related Challenges**

- Heightened risk of SARS-CoV-2 transmission.
- Water supply has been shut off. Central Water and Sewerage Authority (CWSA) advises the general public
  against using stored water supply or the pipe borne supply for anything other than drinking or cooking.
   The use of hoses is strictly prohibited at this time. The CWSA will provide further updates regarding water
  reopening and the plans for scheduled distribution.
- · Water contamination could result in outbreak of water-borne illnesses
- Identify difference between COVID-19 and asthma symptoms
- Increased risk of asthma and respiratory symptoms especially in children
- PAHO in contact with Health authorities Martinique to provide support for possible burn victims. Official requests for medevac to Guadeloupe by PAHO or MoH will be required.
- Potential need for Mass Casualty plan
- Entry requirement for emergency and relief workers on COVID-19 deployment protocol, including requirements for vaccination and quarantining.
- Need for safe water and food in shelters, Medical Oxygen Cylinders and PPEs

## **PAHO Priority Response Actions**

- Damage assessment of health facilities including assessing structural and functional integrity of facilities; assessing water quality
- 2. Strengthening of health emergency operation centres including support to establish alternative medical care sites
- 3. Support to MoH for coordination of international health response
- 4. Assisting with coordination of personnel for provision of psychosocial support
- 5. Maintenance of essential health services, including coordination with Primary Health Care facilities
- 6. Support with shelter management including assisting with set up in line with shelter management guidelines in context of COVID-19
- 7. Infection prevention control through provision of PPEs and medical masks
- 8. Provision of communications materials

## **PAHO Barbados Response Actions**

- 1. Facilitate shipment of 100,000 masks from Barbados to VCT
- 2. Clear container with 60,000 masks, 7,000 N95 masks and 60,000 gowns. To be delivered to Barbados Defense Force.
- 3. Identify available military ships in the region (CMCOORD)
- 4. Review updated COVID-19 protocols for evacuees and deployment of aid workers as shared by CARPHA
- 5. Prepositioning of Non communicable Diseases treatment kits
- 6. Finalize preparations for deployment of 1x WASH expert (Deploy on Sunday April 11, 6.00 am from Barbados to VCT; transport by WFP)
- 7. Ongoing discussions with Hospitals in French Islands to provide services for:
  - a. Burns
  - b. Trauma
  - c. Respiratory services

## **HEALTH CONCERN**

Breathing volcanic ash can be a nuisance, cause discomfort, and may have more serious health effects for some people. You may wish to reduce your exposure to volcanic ash, or you may have been advised to do so.

The most effective way to reduce exposure, especially for people at particular risk (e.g., children and infants, older people and those with existing respiratory (lung) or cardiovascular (heart and blood vessels) disease) is to shelter where there is no exposure to ash, ideally inside a building where you can stay indoors for some time, if necessary. If you are very concerned about your health, take advice from a health professional.
