WHO convention, agreement or other international instrument on pandemic prevention, preparedness and response ("WHO CA+")





Mandate of INB: Decision SSA2(5) (Dec 2021)

"...INB shall determine an <u>inclusive Member State led process</u>, to be facilitated by the co-chairs and vice-chairs, to <u>first identify the substantive elements</u> of the instrument and to then begin the development of a working draft to be presented, on the basis of progress achieved, for the consideration of the INB at its second meeting, to be held no later than 1 August 2022, at the end of which the INB will <u>identify the provision of the WHO Constitution</u> under which the instrument should be adopted..."





Decision at INB3 (A/INB/3/6)

The INB "agreed that, with respect to the zero draft of the WHO CA+, the INB Bureau – with support from the WHO Secretariat – will prepare the zero draft, based on the conceptual zero draft and input received during the third meeting of the INB (INB3), with legal provisions, for consideration by the INB at its next meeting, and as a proposed basis for commencing negotiations at the fourth meeting of the INB (INB4)".





Methodology and approach

- Conceptual zero draft <u>A/INB/3/3</u> (December 2022) is the basis for the work.
- Developing the zero draft was informed by:
 - INB3 interventions, and
 - Existing international instruments of Member States, particularly within the WHO framework.
- Comprehensive section by section review, for example:
 - Reorganized to make the flow better.
 - Consolidated overlaps and repetitions.
 - Added select definitions/terms identified by MS as essential for the discussion.
 - ➤ Revised terminology: "Pandemic-related products" reflects the broader scope of these products that is, they are beyond "response".
